

#200 — Part 2

#200 served the line for 11 years with relatively little issue. Then, about a week before Christmas in 1958, the crankshaft on #200 broke. This was a common problem with the A70T locomotives, and required a complete teardown to replace. #200 would be out of service for almost two months while the crankshaft was repaired, during which time one of the ex-NYOW diesels then being stored in the yard in New Berlin filled in for #200. By February, #200 was back in service, and would soldier on alone until abandonment in 1960.

On the UV, #200 would average nearly 40,000 miles per year in the early years. However, as the line lost customers, #200 would be used less and less. In 1947, when #100 and #200 arrived on the line, the UV was still running daily trains on the northern and southern end of the line, as well as to Edmeston. By 1959, #200 was going out only a few times a week.

#200 served the UV until abandonment in 1960, and pulled the work train that disassembled the line, pulling tracks first from Edmeston to New Berlin, then from New Berlin Junction to New Berlin in the summer of 1960, and finally pulling the tracks from New Berlin to Bridgewater in the fall of 1960.

After abandonment, #200 was sold to the St. Johnsbury and Lamoille County Railroad (StJ&LC, also referred to as the Lake Champlain & St. Johnsbury) by the UV in November, 1960, another railroad owned by Salzberg. They already had a number of GE 70-ton locomotives, all of which were multiple-unit train control (MU) equipped. MU-linked locomotives allowed a single engineer to operate two (or more) conjoined locomotives as a simple operating unit. Because #200 was not MU capable, it was relegated for use as the yard switcher in St. Johnsbury, and was not used out on the line. In StJ&LC service, #200 was assigned engine #55, but was never lettered or renumbered. For the next three and a half years, it served in St. Johnsbury until it suffered a catastrophic

engine failure about April, 1964, probably a broken crankshaft. If so, it would not have been the first such failure for #200, as related earlier.

#200 was never repaired, and became a parts source, setting next to the St. Johnsbury engine house for about four years. Then, about 1968, it was moved in pieces on lowboys to Morrisville, where the StJ&LC had its shops. By then the hood was separate from the frame and other parts had become detached. The hulk of the 200 still sat in the yard until Pinsly (then owner of the StJ&LC) sold some of the yard area and cleaned it up in 1973. That was the final call for the 200, which by then wasn't much more than a frame, and it was cut up for scrap in the yard.


