Postal Service Presents Stamp Reproduction

The stamp chosen

for this presentation was the 20th Century Limited. That train has been called a "national institution" and "the most famous train in the world." With its super-fast 16-hour schedule between Chicago and New York, it catered to business travelers. In 1938, designer Henry Dreyfuss redisigned its J-3a steam locomotive and Pullman cars.

Service. This presentation would not have taken place, however, had it not been for the efforts of Mrs. DeRidder and Mr. Lindsay from the New Berlin post office.


